




Public Market Trends


Pool & Spa supplies wholesalers realized compressed earnings due to weak discretionary spending, a trend expected to ease in coming months


June 2024 Season Update

Recent Transaction Activity


Transaction activity has remained steady in recent years as the industry performs well and M&A continues to be in focus for key players across the sector
